## VENDOR APPLICATION-CONTRACT

1. It is agreed that the vendor will fill out, sign and return this contract.
2. It is agreed that spaces will be rented for the entire event and that the vendor for the duration of the event will tend to booth. Vendors must be open for business at 8am and may not close before 9pm. It is further agreed that there will be no subleasing of space. All vendors sharing a space and selling merchandise must sign contract.
3. It is agreed that any objects exhibited or sold will be his/her responsibility at all times, and vendor shall be responsible for his/her safety and bear any loss by reason of theft, breakage, or other casualty.
4. It is agreed that vendor will comply with any and all requirements of any government authority be it federal, state or local – and to indemnify and hold harmless the promoters and or owners, facility own and all its constituents, from any and all liability due to failure to comply with any regulations.
5. It is agreed that the promoters reserve the right to make further rules and regulations and such changes regarding this event as they deem necessary and proper. Upon notice to the vendor all said action should become part of this contract and binding on the parties hereto.
6. It is agreed that the vendor will release the promoters and the show facility owners and all its constituents from any and all liability for damages, injury or loss to any person or goods from any case whatsoever and further agrees to indemnify the promoters from any and all claims for damage, injury or loss
7. It is agreed that in the best interest of the public and other vendors that all pets will remain restrained at all times.
8. It is agreed that violators of these rules constitute expulsion of event and or non-participation of any future events.
9. **IT IS AGREED THAT ALL VENDOR SPACE FEES ARE NON REFUNDABLE.**
10. **Biker Rallies of Texas LLC** has the exclusive right to display, license, sell and merchandise all event novelties (t-shirts, patches, pins and or any item with logo). **Biker Rallies of Texas LLC** further has the right to inspect, approve, reject or otherwise control the display, promotion, sale or other merchandising of products or services be vendors at the event in its sole discretion. Any product or services rejected must be immediately removed from the event premises and may be removed by **Biker Rallies of Texas LLC** if this does not occur.
11. Merchandise designed to be passed off as event merchandise (use of Bandera, rally dates, event names, trademark, etc.) or which has this effect will not be permitted. No signage may be displayed in vendor space reading “Rally Merchandise” “Rally Tee’s”, “Event Tees” or any similar language advertising the sale of event merchandise. “THUNDER IN THE HILL COUNTRY” “RUMBLE ON THE RIVER” “IRON ANGELS” is a trademark of **Biker Rallies of Texas LLC**. Any vendor found selling merchandise that infringes on these trademarks may be asked to leave immediately and will be subject to legal recourse.

Set up will begin WEDNESDAY at 8a.m. – 8p.m. **NO** vehicles will be permitted on the grounds during the evening until all pedestrian traffic has stopped unless instructed otherwise.

ALL vendors must be open and ready to the public at 8a.m. when activities start.

**ARRIVAL INSTRUCTION: GO TO THE REGISTRATION DESK.**

Non-food vendor spaces are purchased as a 4 day event. Tear down/move out will be on Sunday. Vendor spaces are sold in increments of **10x20** per space **OUTSIDE, INSIDE**. Your packet will come with **TWO** armbands. Any additional armbands will need to be purchased at registration. Applications are on a first come, first serve basis. In order to guarantee your spot you must be **PAID IN FULL** by MARCH 1<sup>st</sup>. Applications after MARCH 1<sup>st</sup> will be permitted if space is available. Electricity will be provided for **INSIDE** vendors with **(1)** One 110 plug. (if more than one plug is needed there may be additional fees). **Outside vendor must supply their own electricity**. Please keep in mind that all vendors will be side by side and that it is important to keep your **ENTIRE** display within your area.

(In order to guarantee the same spot you purchased in any previous rally with Biker Rallies of Texas you must have confirmation with the **MANAGEMENT** and made a **50%** deposit **BEFORE** leaving. The same will apply at each rally).

We will have water for your convenience and ice will be available for **PURCHASE** on the grounds. You (vendors) are responsible to bring your own water hose or container.

Biker Rallies of Texas wants to provide a well-rounded rally with entertainment, excitement and a profitable opportunity for **ALL** our vendors. Once again, please fill out all paperwork (vendor application and vendor contract) and send them to us with payment to secure your spot with us.
