Dear Vendor / Dealer,

Biker Rallies of Texas presents Thunder in the Hill Country on Thursday, Friday, Saturday and Sunday March 29<sup>th</sup>, thru April 1<sup>st</sup>, 2012

Thursday's activities will start at 6:00 pm. Friday & Saturday activities will start at 8:00 am. Set up will begin on Wed. at 8:00 am – till midnight. NO vehicles will be permitted on the grounds in the evening until all pedestrian traffic is gone. No setup on Thursday.

Non-Food Booth spaces will be rented as a 3-day event. Tear down/move out will be on Sunday. **Vendor spaces rent in increments of (10x20) for \$200.00 per space outside and \$400.00 per space inside. This includes entry for 2 people only. Food Booth spaces are \$500.00 for a (10x20). (THIS INCLUDES ENTRY FOR 2 PEOPLE ONLY—ALL OTHERS WILL HAVE TO PURCHASE A TICKET AT REGISTRATION)** Applications will be on a first come, first serve basis. In order to reserve your space we must have your **application and rent check in our office ASAP.** Applications received after March 1st, will be admitted if space permits. Electricity will be provided only to inside vendors. **(1 one 110 plug only).** Outside vendors must supply own electricity. Your entire display must fit inside the purchased space with no overlap.

We will have water available for your convenience. The vendor is responsible for having a container or hose to carry the water. Ice will be available for purchase inside the grounds.

We want to provide a well-rounded Rally and a good opportunity for all of our vendors to have a profitable showing. An application and contract are enclosed with this letter. The application and contract needs to be filled out completely and returned ASAP. Late applications will be accepted on standby. Notification of acceptance will be e-mailed to you shortly after receipt of your application and check. **Once again, If we do not receive your check in this office, you will not be guaranteed a space. Spaces must be paid in full up front, if you show up without paying, you may not be allowed in.**

Thank you for your cooperation. We are looking forward to seeing you at this year's Thunder in the Hill Country.

# THUNDER IN THE HILL COUNTRY BANDERA, TEXAS

1. It is agreed that the Exhibitor will fill out, sign, and return this contract.
2. It is agreed that booths will be rented for the entire show and that the Exhibitor for the duration of the show will tend booths. Vendors must open for business at 8:00 am sharp and will not close their booth before 7:00 pm. Vendors will be allowed to remain open for as long as they wish after 7:00 pm. It is further agreed that there will be no subleasing of booth space. ALL EXHIBITORS SHARING A BOOTH AND SELLING MERCHANDISE MUST SIGN CONTRACT.
3. It is agreed that any objects exhibited by the Exhibitor be his/her responsibility at all times, and Exhibitor shall be responsible for his/her safety and bear any loss by reason of theft, breakage, or other casualty.
4. It is agreed that Exhibitor will comply with any and all requirements of any government authority be it federal, state, or local – and to indemnify and hold harmless the promoters and the show facility owners, and all its constituents, from any and all liability due to failure to comply with any regulations.
5. It is agreed that the promoters reserve the right to make further rules and regulations, and such changes, regarding this event as they deem necessary and proper: and upon notice to Exhibitor all said action should become part of this contract and binding on the parties hereto.
6. It is agreed that the Exhibitor will release the promoters and the show facility owners and all its constituents from any and all liability for damages, injury or loss to any person or goods from any cause whatsoever, and further agrees to indemnify the promoters from any and all claims for damage, injury or loss.
7. It is agreed that, in the best interest of the public and other vendors, that Exhibitor will not bring into the festival grounds any dogs, cats, or other animals.
8. It is agreed that violators of these rules may constitute non-participation in future rallies.
9. **IT IS AGREED THAT ALL VENDOR SPACE FEES ARE NON-REFUNDABLE.**
10. **IT IS AGREED THAT VENDOR SPACE FEES ARE PAYABLE UP FRONT; NO FEE'S WILL BE COLLECTED AT THE RALLY SITE.**
11. Biker Rallies of Texas has the exclusive right to display, license, sell and merchandise all event novelties (t-shirts, ride pins, etc.). Biker Rallies of Texas further has the right to inspect, approve, reject or otherwise control the display, promotion, sale or other merchandising of products or services by exhibitors at the event in its sole discretion. Any products or services rejected by Biker Rallies of Texas must be immediately removed from the event premises and may be removed by Biker Rallies of Texas if this does not occur.  
**Merchandise designed to be passed off as event merchandise (use of Bandera, rally dates, event name, trademarks, etc.) or which has this effect will not be permitted. No signage may be displayed in Exhibitor space reading "Official Rally Merchandise", "Rally Merchandise", "Rally Tees", "Event Tees" or any similar language advertising the sale of event merchandise. "THUNDER IN THE HILL COUNTRY" is a trademark of Biker Rallies of Texas. Any vendor found selling merchandise that infringes on these trademarks maybe asked to leave immediately and will be subject to legal recourse.**
