Dear Vendor / Dealer,

Biker Rallies of Texas presents Thunder in the Hill Country on Thursday, Friday, Saturday and Sunday March 28th thru March 31st 2019. Thursday, Friday and Saturday's activities will start at 8:00 am.

Vendor Set-up/Tear-Down: Vendor's will set-up Wednesday, March 27th and tear-down Sunday, March 31st. Vendor Registration will be open from 8:00am until 10:00pm*. **ALL** vendors will be escorted to their booth location.

***Vendors not expecting to arrive until after 10:00pm, please call.**

Vendor Booth Rates* being at: (Booth must fit inside space purchased)

- FOOD: \$500 (10x20) - Electricity provided as needed
- INSIDE: \$400 (10x20) (\$2.00/sq. ft.) - Electricity provided, one (1) 110 plug ONLY
- OUTSIDE: \$200 (10x20) (\$1.00/sq./ft.) – Must provide own electricity

***Call for exact booth rate for other than 10x20. Includes 2 armbands, additional armbands may be purchased for \$25 per person. Water is available, must have own hose or container. Ice may be purchased on the grounds.**

Application/Contract Deadline: A minimum of a \$100 Deposit MUST be received prior to March 1st to ensure your space, with payment in FULL by March 1st. Application required for all NEW vendors (unless previously submitted vendor applications need to be changed). Rally specific contract must be signed by **ALL** vendors.

1. It is agreed that the Exhibitor will fill out, sign, and return this contract.
2. **It is agreed that booths will be rented for the entire show and that the Exhibitor for the duration of the show will tend booths. Vendors must open for business at 8:00 am sharp and will not close their booth before 7:00 pm. Vendors will be allowed to remain open for as long as they wish after 7:00 pm.** It is further agreed that there will be no subleasing of booth space. ALL EXHIBITORS SHARING A BOOTH AND SELLING MERCHANDISE MUST SIGN CONTRACT.
3. It is agreed that any objects exhibited by the Exhibitor be his/her responsibility at all times, and Exhibitor shall be responsible for his/her safety and bear any loss by reason of theft, breakage, or other casualty.
4. It is agreed that Exhibitor will comply with any and all requirements of any government authority be it federal, state, or local – and to indemnify and hold harmless the promoters and the show facility owners, and all its constituents, from any and all liability due to failure to comply with any regulations.
5. It is agreed that the promoters reserve the right to make further rules and regulations, and such changes, regarding this event as they deem necessary and proper: and upon notice to Exhibitor all said action should become part of this contract and binding on the parties hereto.
6. It is agreed that the Exhibitor will release the promoters and the show facility owners and all its constituents from any and all liability for damages, injury or loss to any person or goods from any cause whatsoever, and further agrees to indemnify the promoters from any and all claims for damage, injury or loss.
7. It is agreed that violators of these rules may constitute non-participation in future rallies.
8. **IT IS AGREED THAT ALL VENDOR SPACE FEES ARE NON-REFUNDABLE.**
9. **IT IS AGREED THAT VENDOR SPACE FEES ARE PAYABLE UP FRONT; NO FEE'S WILL BE COLLECTED AT THE RALLY SITE.**
10. Biker Rallies of Texas has the exclusive right to display, license, sell and merchandise all event novelties (t- shirts, ride pins, etc.). Biker Rallies of Texas further has the right to inspect, approve, reject or otherwise control the display, promotion, sale or other merchandising of products or services by exhibitors at the event in its sole discretion. Any products or services rejected by Biker Rallies of Texas must be immediately removed from the event premises and may be removed by Biker Rallies of Texas if this does not occur.

Merchandise designed to be passed off as event merchandise (use of Bandera, rally dates, event name, trademarks, etc.) or which has this effect will not be permitted. No signage may be displayed in Exhibitor space reading "Official Rally Merchandise", "Rally Merchandise", "Rally Tees", "Event Tees" or any similar language advertising the sale of event merchandise. "THUNDER IN THE HILL COUNTRY" is a trademark of Biker Rallies of Texas. Any vendor found selling merchandise that infringes on these trademarks may be asked to leave immediately and will be subject to legal recourse.
